STATEMENT 1 – Dave Redgewell

We are very concerned to see the high risk statement in the Audit report for Public transport Network.

Especially the Demand responsive bus services with bus drivers risk .

But we would also raise the risk of the contract not being awarded to Abus or coach company for Demand responsive bus services as in Somerset Gloucestershire and Wiltshire.

With Somerset county council own bus and coach company.

Pulham coaches in Gloucestershire and lydney dial ride bus services

Go ahead group South Coast bus services in Wiltshire

But it maybe that we Demand responsive bus services and via can get agency drivers for the Network in North Somerset council Banes South Gloucestershire council and part of Greater Bristol but apart from Bristlington keynsham Totterdown and Avonmouth this service is in Deep rural areas.

It does not replace the secondary bus Network in Greater Bristol and Bath.

Which will be withdrawn on the 1st April 2023 and June 2023 .

Leaving many communities without public transport in North East Somerset South and East Bristol and Towns in south Gloucestershire.

Leaving major bus Network caps

We welcome the 7 million pounds award of a contract to enhance bus service corridor sto first group plc west of England buses to enhance peak hour service on the following routes.

In East Bristol we have been left with no bus service for 1 st April 2023 .

By the west of England mayoral combined transport Authority.

Bristol city council and south Gloucestershire council failing to fund

Our local bus service 47 from

Bristol city centre to st Paul's, st werburges,Eastville park , Fishponds road oidbury court ,Downend ,Emerson green, Westerleight,puckchurch Yate bus and Yate North.

We have also loss the bus section of the route through Stapleton village and Broomhill on the old number 5.

Before it became the 47.

It would the the west of England mayoral combined transport Authority has failed to carry out any public consultation about the loss of the bus service or any equilities impact assessments.

The route provides a service to the West of England disabled living centre and the st Paul's learning centre living communities cut of from Public transport.

The Duty to provide support bus service by act of parliament for the west of England mayoral combined transport Authority is the mayor Dan Norris jointly with Bristol city council and south Gloucestershire council.

The responsibility to provide the bus service is through the Transport levy.

That Bristol city council Banes and South Gloucestershire council.

By the council he Frozen the levy .

We have no understanding how the mayor is spending \pounds 7 million of taxpayers money on core bus services in Greater Bristol with public consultation

on a contract with First group plc.

But the only bus corridor in our area .

Are Gloucester Road or Fishponds road.

A very very long walk from st werburges or st Paul's or oidbury court estate.

The 47 Bristol st Paul's ,st werburges Eastville park ,Fishponds, road oidbury court, Downend,Emerson green puckchurch westerleight yate bus station. Should have been made a bus service improvement plan route .

We do not how the Northern end of the bus route was keep from Emerson green puckchurch westerleight yate bus station and yate North.

We kept to be operated by stagecoach west .

But not the areas in need of a bus service to access, Work ,school ,college hospital ,heath services and food shopping

The west of England mayoral combined transport Authority has carried out no public consultation on our bus route .

At today meeting our bus route is considered to be very high risk it being withdrawn by the Authority.

Without any consultation with the community that fund the service through council tax.

West of England mayoral combined transport Authority is now telling Great Bristol is the new London Transport on Television or Richard wyatt of Former HTV and Bristol TV is being used to tell us we are getting Demand responsive bus services in Greater Bristol.

But this not true in East Bristol or south Bristol where bus service are withdrawn

In large numbers on 1st April 2023

I would appear to communities and people that are struggling with the cost of living crisis the west of England mayoral combined transport Authority is

Not on the side of passengers in the poorest communities of Greater Bristol.

It is interesting that the present value for money test for £ 7 million pound of bus service improvement plan money.

Is being spent on what the American cull middle class transit routes of main line bus services.

As East Bristol is left without bus services including the loss of 506 Bristol city centre st Phillips ,Lawrence hill Easton, Eastville,Horfield Southmead hospital bus station

and Evening bus service on service 17 Keynsham town centre ,kingswood corsham hospital, Hillfield, staple hill Fishponds Eastville park Horfield Southmead hospital bus station .

We would ask the Audit commission to look at how the West of England mayoral combined Authority is spending taxpayers money on Bus services and how its Governance is failing to consult

With inter city communities.

Whist we welcome Ashley Down station.

In the Future it's to far to walk and 506 bus service is withdrawn to the new station.

We would ask the Audit commission to make recommendations about the way the mayor of the west of England Dan Norris is spending taxpayers money on bus services and look at Bus services improvement plan money on service 47 a new Transport for London bus corridor Bristol to Downend bus corridor which could start at Ashton vale,Southville Bristol Temple meads station city centre Broadmead shopping centre st Pauls st werburges Eastville park Stapleton Broomhill, Fishponds,oidbury court Downend, Bromley heath, winterbourne and Frampton cotterel

<mark>Statement 3 – Catherine Carter</mark>

Many residents, myself included, are shocked and incensed that our local bus route, the number 47, will be withdrawn on 1st April 2023. This is the only bus running through St Werburghs and most of St Pauls. How can it be that an area within the vicinity of the city centre now has no means of public transport?

A 5-10 minute bus journey is now at least a 30 minute walk. The nearest alternative bus route, Stapleton Road, is a 15-20 minute walk away which involves crossing the motorway bridge and walking down poorly lit roads. This is simply not accessible for those with mobility issues and would feel unsafe for many others. As the city is so poorly connected as it is, adding a 30 minute walk to a journey that already often involves two buses, travel time will significantly increase, especially as there is often a knock-on delay to buses on Stapleton Road because of congestion on Fishponds Road during peak hours.

Many of my neighbours, including within my household, are key workers who work long and irregular shifts. Residents who work at the BRI and other NHS facilities in and around the city, now have no alternative but to walk home during unsociable (and often less-safe) hours, and after gruelling 12 hour shifts. We should be supporting our Key Workers, not making their lives harder by cutting local services. The same is also true for those who use the number 47 to get to the BRI for medical care, with the alternative service to Southmead hospital, the 506, also being cut. I know of several key workers who have had to move out of the area simply because they can't get to work.

The reason given for the cutting of the 47 is 'low passenger numbers'. I don't believe this to be true and can be explained, at a very basic level by the following:

1. It is a very long bus route and therefore would never be at capacity the entirety of its journey. It is often full as it runs through St Werburghs/St Pauls during commuter hours. Perhaps a bus with a shorter route would be more viable.

2. It is unreliable and this has likely lead to a drop in customer numbers. I know locally that many students have had to already forgo using the bus because they simply can't rely on it to get to school/college on time. Personally, there have been many times that the buses due to run in the busiest times have been cancelled, passenger numbers will inevitably be low if the one hourly bus they need to get to/from school/college/work isn't running.

Bristol declared a climate emergency in 2019, having effective public transport is a key part of reducing pollution in the city and worldwide. The Brooks Dye Works development in St Werburghs brought hundreds more residents to the area, now with no local means of bus travel. For those fortunate enough to own and run a car, this will increase pollution and congestion on the local

roads. For local residents without a car, of which there are many, we feel we have been cut off. The cost of living crisis means that now, more than ever, people are reliant on public transport.

Vulnerable members of our local community will become isolated without this bus service, 40% of people with mobility issues don't have access to a car (Age, UK). Even more pressure will now be put on charities to pick up where the local authority and the government are falling short. Not only will it restrict the accessibility of amenities to older people, they will now have no means of getting even their basic food shopping from the supermarket at Eastgate.

I am asking you to please acknowledge and act upon the issues I have outlined above.

It will not work for the miles of South Bristol.

We were told that we were get new .

Bus service improvement plan bus service across South Bristol.

521 Bristlington to Hengrove via the Hospital.

524 Long Ashton park and ride to Hartcliffe and Hengrove hospital.

But no service appear to be going to operator from 1st April 2023.
