**Decision Title**: Low Carbon Challenge Fund – Green Business Grants

# Background / reason for decision:

Delegated authority has been granted to the Combined Authority Chief Executive to take decisions on the award of Green Business Grants (through the Low Carbon Challenge Fund) in consultation with the Chief Executives of the West of England unitary authorities.

Green Business grant applications were considered as follows:

Approximate annual savings analysis of the proposal: \* Annual greenhouse gas emissions: 113.2tCO2e

\* Annual energy use: 21.4% on gas use

\* Annual energy cost: £12,792 on energy bills

Green Business grant applicant: The Bath Pub Company Ltd

Sector: Accommodation and food services

Local authority area: Bath & North East Somerset Project description: Installation of induction appliances

Project timescale: June 2021

Approximate annual savings analysis of the proposal:

- \* Annual greenhouse gas emissions: 7.2 tCO2e
  \* Annual energy use: 28% on overall energy use
- \* Annual energy cost: £1,953 on energy bills

Green Business grant applicant: Ontel Services Ltd

Sector: Information and communication

Local authority area: Bristol

Project description: Installation of heat pumps and solar PV panel

Project timescale: June - August 2021

Approximate annual savings analysis of the proposal:

- \* Annual greenhouse gas emissions: 3.3tCO2e
- \* Annual energy use: 50.1% on electricity use.

\* Annual energy cost: £1,035 on energy bills

The above applications were assessed by officers as meeting the required criteria in terms of value for money, deliverability and financial viability.

The Chief Executives of the West of England unitary authorities were consulted on these proposals and were in agreement with the decision.
