Details:

The project is part of the CRSTS programme, aiming to deliver interventions supporting modal shift into public and active travel modes across the region. In particular this project strategically complements the Bath City Centre, Bristol to Bath, and Somer Valley corridor projects through providing high quality walking & cycling links to and from key destinations through and around the city, supporting a decrease in private car dependency.

Please note that £62,000 of the £362,000 referenced is TCF capital that has already been re-allocated by Committee as part of a project integration decision with the Weston to City Centre scheme. However, this FDAF details the spend of the combined budget with the £300,000 CRSTS capital as it is the same workstream.

- 7. Please describe the scheme to be developed (including its objectives and expected impacts) and the proposed activity to be undertaken through this investment.
- A. Details of the scheme to be delivered:

The Bath Sustainable Transport Links scheme aims to provide a continuous cycle route with local pedestrian improvements between the north-west and south east-quadrants of Bath linking into the City Centre and Bristol to Bath corridor, and connect the Royal United Hospital to key routes into the city centre and beyond.

The project has been divided into 4 schemes, as follows:

- All Saints Primary School, Weston, to Bath city centre (LCWIP Bath cycle route 1, page 81).
- Royal United Hospital Links:
 - Hospital to NCN4 & NCN244 at Bath Spa University Locksbrook Campus/Fieldings Bridge, plus Locksbrook Road cycle facility between Avondale Road and Station Road, to enable cycles to travel eastbound, providing improved access to and between NCN4 and NCN244.
 - Oldfield Secondary School to Locksbrook Road (LCWIP Bath cycle route 3, section 1 & 2, page 84, plus LCWIP Bath walking route 2, sections 1 to 5,

- NCN4 Great Pulteney Street to Kennet and Avon Canal at A36 Beckford Road, improvement/diversion of NCN4 plus pedestrian improvements (LCWIP Bath walking route 1, sections 8-11).
- Valley floor to Claverton Down cycle route via either North Road, Bathwick Hill or Widcombe Hill.

The Preferred Option Report will summarise the progress towards a robust and deliverable preferred intervention across the five dimensions for the project ready to seek approval for funding to complete the Full Business Case. Details:

The project will be managed by the West of England Combined Authority Capital Delivery Team, who will be Accountable and Responsible for the project within the overall programme. Officers from B&NES will sit in the joint project team and will provide the technical input and work on the scheme design and development. Work requirements and resource funding between the two organisations will be managed via the Activity Assignment Form process

The project will advance the schemes described through to the completion of option assessment and preferred option selection in line with the 5 case model and TAG, outline design and public consultation, final outline design and confirmation of scope for the Full Business Case in the next funding phase.

A consultant will be procured by the Combined Authority via the Professional Services Framework to undertake the design and TAG elements, including option assessment exercises and outputs, design drawings and necessary surveys, consultation preparation, risk registers & QRAs.
