### **Response:**

The refresh to the Bus Service Improvement Plan (BSIP) policy is being delivered in line with guidance set out by the Department for Transport (DfT). Submission has to be by 12 June 2024 to enable year 3 funding for the current phase of BSIP delivery and set out policy for any future funding opportunities that may become available. The refresh has to go through the Enhanced Partnership process with formal meetings in May and

consultation will take place with a wide range of partners and stakeholders ahead of submission.

The Equalities Officer recruitment is underway.

## Question JC2

With the west of England mayoral combined Authority being in special measures with the Department for levelling up and the setting up on a panel by the secretary of state for levelling up Michael gove,

What progress is now being made on merging the local Enterprise partnership and North Somerset council into the west of England mayoral combined Authority for mayoral Elections in may 2025  
It appears that we will be the last South west local Authority to merger the local Enterprise partnership in the combined Authority

As Devon, and Somerset are merging Heart of the south west local Enterprise partnership as is Cornwall, Dorset Council and Wiltshire and Swindon Gloucestershire,

## Question JC3

**From Ian Beckey**

What is latest progress on Reopening the Bristol Temple meads station, Bedminster, Parson street, pill and Portishead, for 2027 opening of the line including bus rail Interchange at pill and Portishead,

To link with local bus services.

Including the passive provisions for a station in Ashton Gate,

**Response:**

Detailed design is progressing for the re-opening of the Portishead Branch Line, which includes new stations at Pill and Portishead, by the rail industry and its supply chain. The design includes bus interchange infrastructure, for both new stations.

A full business case (FBC) is being prepared for submission to the Department of Transport (DfT). Approval of the FBC is a significant milestone for the region unlocking funding from the Department and enabling construction works to commence. The working programme, subject to funding from the DfT sees works commence on re-opening the railway line to Portishead later this year.

A station at Ashton Gate is being considered within the Mayoral Combined Authority's new station study as presented at January 2024 Committee. The study will review the feasibility of potential new stations across the West of England Region. The design for re-opening of the Portishead Branch does not preclude a potential new station at Ashton Gate in the future.

With the 126 services from Weston super mare bus and coach station interchange, weston super mare Raiway station uphill Hospital weston super mare, Hutton, Banwell Winscombe Axbridge cheddar, Draycott Westbury sub Mendip Draycott Easton Wells bus and coach station, This service inchanges with westlink Demand responsive bus services at Axbridge for the Chew valley.

What is level of service and the zone this that services 126 will link into at Axbridge and how far will the 20 mins zone cover ,

**Response:**

The zone will continue to follow the North Somerset Council boundary and residents using service 126 will be able to interchange with the WESTlink service in Winscombe, Sandford and Banwell. Passengers will be able to use WESTlink services to travel to Blagdon and Bristol Airport, however a change of service will now be required to travel to Chew Valley. Full details on the zone changes will be available shortly.

## Question JC6

With the submission of the west of England mayoral combined transport Authority and North Somerset council bus service improvement plan to the Department for transport by 12th June 2024 What discussion are happening with unity Somerset council to make sure the bus network in Somerset North Somerset council and West of England mayoral combined Authority are co ordinated ,

On route like service 375 Bristol bus and coach station, Whitchurch Pensford Clutton Farringdon Gurney Chewton Mendip Wells bus and coach, Glastonbury, street and Bridgwater Railway station and the bus station

Or services 374 Bristol bus and coach station to Bristol Temple meads station, Totterdown Knowle Hengrove Whitchurch Pensford Clutton Farringdon Gurney Chewton Mendip Wells bus and coach station, Glastonbury and street and Taunton,

Services 20 Weston super mare bus and coach station Railway station Uphill Hospital, Brean and Berrow and Burnham on sea 21 for Highbridge, Bridgwater bus and coach station and Taunton, 171, 173 174 Wells bus and coach station to Chilcompton or Shepton mallet interchange, midsomer Norton Westfield Radstock Peasdown st john Bath spa bus and coach station,

All are part of a Somerset network

So will the west of England mayoral combined transport Authority and North Somerset council and Somerset council co ordinate information for their bus service improvement plan also with Wiltshire Council Swindon Borough Council, Gloucestershire county council and western Gateway Transport Board and Peninsula Transport Board,

### Response

The Mayoral Combined Authority does liaise with other authorities relating to established cross boundary services, although this does not extend to a wider network planning brief beyond the unitary authorities (UAs) that make up the West of England Mayoral Combined Authority. The West of England Mayoral Combined Authority, and its constituent UAs, do have long-established collaborative working practices with neighbouring boundary authorities.

North Somerset Council does have a collaborative relationship with Somerset Council and with each of the West of England Mayoral Combined Authority UAs.
